

Terms of Services

This Terms of Service document (the “Terms”) outlines the terms and conditions of use of the **VPN** services (the “Services” or “Service”) provided by **VPN Guard - Safe & Secure**. By agreeing to these Terms, you are also agreeing to the Privacy Policy (“Privacy Policy”).

Please read these terms of service carefully. among other things, they provide key information on your legal rights and obligations, future changes to the terms, automatic renewals and limitations of liability.

1. Acceptance

By accessing the Content or Services, you are agreeing on behalf of yourself or those you represent (“you”) to comply with and be legally bound by these Terms in their entirety. These Terms constitute a legally binding agreement (the “Agreement”) between you and **VPN Guard - Safe & Secure**. If you do not agree with any part of the Terms, you may not use our Services.

By using our Services, you represent that you are at least fourteen (17) years of age or that you are a valid legal entity, and you are agreeing to these Terms and Conditions. Please read them carefully as they constitute the Terms and Conditions of a legally binding agreement between you and the company.

When you agree to use our Services, Virtual Private Network ("VPN"), which includes, but is not limited to, the use of our servers, routers, IP addresses, protocols, add-ons, software, applications, and other equipment, you authorize us to transmit information using our network, and you agree to accept the Terms with respect to your use of our VPN Services.

Using our Services, even after any change in Terms, will mean that you agree to these Terms. If you don't feel comfortable with agreeing to these Terms as they are, please stop using our Services, although we'll be sorry to see you go.

2. Subscriptions

VPN Guard - Safe & Secure Services are available to you upon acquisition on the App. By subscribing to the Services, you agree to become a subscriber (“Subscriber”) for the period you have elected. A full list of subscription plans and pricing is available on the app. **VPN Guard - Safe & Secure** reserves the right to amend subscription fees or institute new fees at any time upon reasonable advance notice posted on the App or sent via email. Any changes to the pricing will not affect the Subscriber’s current subscription period and will become effective upon subscription renewal. Subscription purchases and refunds are handled via multiple third-party payment companies.

Users whose subscriptions are billed as an in-app purchase through the Apple App Store (iTunes) can request refunds through the App Store, which are issued solely at the discretion of Apple Support.

3. How We Protect You

We do not log any user activity (sites visited, DNS lookups, emails etc.) We only log access attempts to our servers (for security and troubleshooting). We do not get involved in any form of censorship. We do not sell your personal info to any third parties. We do not cooperate with any requests for information unless we are ordered by a court of competent jurisdiction and the vast majority of these requests would not be from a court of competent jurisdiction. We will protect you to the max and our system is setup to automatically do so. There are hundreds of good reasons for being anonymous and we respect them fully.

4. Acceptable Use Policy

In using our Services, you agree to that:

Hacking, cracking, distribution of viruses, fraudulent activities, network sabotage, phishing, and/or any conduct deemed illegal or unwanted shall be subject to suspension or termination.
